Ms. Byerrum reported on the December financial statements. Operating expenses are at 48%.

11.3 General Manager

Mr. Kolisz informed the Board that during the 2 ½ year pilot study at the Treatment Plant it has been discovered that there is a cost savings in using a larger size media as it outperforms the current mesh media. The District will continue replacing the media, as needed, moving forward.
