## 2. <u>Consideration of Contract Award to Provide Design Services for Fluoride</u> <u>Treatment Plant Wastewater Pond #3</u>

Staff recommends that the Board approve the bid on design services for pond #3 with Kennedy/Jenks Consultants and direct staff to enter into a professional services agreement. Requests for proposals were circulated to seven contractors with only one returned proposal submitted.

After discussion, Director Bourikas moved to award the contract to Kennedy/Jenks Consultants to provide design services for the fluoride treatment

plant wastewater pond #3 in the amount not to exceed \$103,900, seconded by Director Horn and approved by the following roll call vote.

### 3. <u>Consideration of Emergency Generator Reimbursable Expenditure Contingent Upon Approval from MDAQMD</u>

The expense will be reimbursed by ACWA/JPIA upon completion of the project. As of today, MDAQMD approved the application.

#### 6.1 Operations

Mr. Kolisz reported that the District responded to 25 Underground Service Alerts, 0 water main leaks, 1 blown meter, performed 4 leak audits, and had 1service line leak. Production continues to trend downward. Final ruling for chromium 6 levels are expected to be announced by the Department of Health in April.

### 6.2 Finance

Mr. Josh Byerrum reported that the District is tracking as expected. A brief summary was given for current projects including upgrades to the

financial/billing software. Staff will be trained on site once the system is implemented with an expected start date of July 1<sup>st</sup>.

### 6.3 <u>General Manager</u>

Ms. Alaniz reported that the County Board of Supervisors, after pulling the item for discussion, denied the Board's request to change the election date as it was cost and labor prohibitive. The Regional Water Quality Control Board was in favor of the Salt Nutrient Management Plan being included in the Ground Water Protection Plan. The application to the State Water Revolving Fund was received and is under review. The Board will be holding a Fire Workshop on Saturday, March 29<sup>th</sup> at 9:00 a.m. Twentynine Palms Water District will be participating in the Water Education Day being held on Sunday, March 30<sup>th</sup> from 1:00 p.m. – 4:00 p.m. at the Joshua Basin Water District.
