One involved assisting the National Park Service in a small vegetation fire. New legislation was passed allowing fire employees from CalPERS to transfer retirement and liabilities to the San Bernardino County retirement system. The Ad Hoc committee met twice since the last Board meeting. The committee was presented with a history of the department's finances and provided with a service model presentation by Division Chief Chamberlin.

Six paid call firefighters participated in the month of June.

Terry Hinderliter, of Twentynine Palms, was in favor of the Fire Department charging for medical aid calls.
