Public Comments

Ed Vallerand, of Twentynine Palms, spoke to Agenda Item #1 asking that a copy of the survey questions and results be made available to the public for review.

1. Report, Discussion, and Possible Actions Related to Community Survey Conducted by The Lew Edwards Group and FM3 Research

Chief Thompson introduced Adam Sonenshein of FM3 who gave a Powerpoint presentation on the Twentynine Palms Water District Fire Department Measure Feasibility survey. The following are highlights of the survey results.

- 40% of the community polled feel the community is headed in the right direction with 36% opposing.
- Support was shy of the two thirds requirement for passage for the hypothetical ballot measure when participants were asked if they would vote yes in favor of an increase parcel tax by \$32 per unit for 10 years with annual independent audits, citizens' oversight, and requiring all funds be used for fire protection/emergency services only.
- 68% were in favor of a \$12 per unit increase as opposed to the 26% against.
- Voters felt protecting 911 emergency/medical response services was the most important.
- 69% were much more inclined to vote for the measure if it meant the passing would result in the re-opening of the Lear Avenue Fire Station.
- The Lew Edwards Group/FM3 recommends that the District engage in a community outreach effort before proceeding with a ballot measure as the results of the poll is within and not above the margin of error and results show a consistent percentage opposed the \$32 per unit ballot measure.

After discussion, which included Chief Thompson's recommendation to suspend the contract with The Lew Edwards Group, Director Chambers moved to suspend the contract with The Lew Edwards Group, seconded by Director Shinaver and approved by the following roll call vote:
