### **BACKGROUND**

At the July 27, 2016 Board of Directors Meeting, Director Chancey Chambers submitted his resignation to the Board of Directors effective that day. The term of office vacated by Director Chambers expires on December 1, 2017.

### DISCUSSION

When a vacancy occurs, the Board may fill the vacancy either by appointment or by calling an election. With the effective date of the vacancy of July 27, 2016 the seat must be filled within 60 days which is no later than September 25, 2016. The regular schedule meeting of the Board of Directors is on September 28, 2016.

<u>Election:</u> The Board may within 60 days of the date of the vacancy call an election to fill the unexpired balance of the term of office. Having an election involves a cost to the District of several thousands of dollars.

<u>Appointment:</u> In lieu of an election, the members of the Board can make an appointment within 60 days after the effective date of the vacancy for the unexpired balance of the term of office. The District shall post a Notice of Vacancy in three or more conspicuous places in the District, at least 15 days before the District Board makes the appointment. The District shall notify the county elections office of the appointment no later than 15 days after the appointment.

The appointment process would invite interested registered voters who reside within the District boundaries to submit letters of interest, resumes and possibly a supplemental questionnaire (Package) to the District. To allow sufficient time for interested parties to complete the Package and adequate time to post the Notice of Vacancy staff is recommending the options below for consideration.

<u>Option #1:</u> Appoint a new Director at a special meeting of the Board of Directors on September 7, 2016. This would set a deadline date for interested parties to submit their Package by 5:00 pm on September 2, 2016.

Option #2: Change the regular scheduled meeting date of the Board of Directors on September 28, 2016 to September 21, 2016 to appoint a new Director. This would set a deadline date for interested parties to submit their Package by 5:00 pm on September 16, 2016.

Option #3: Appoint at the regular scheduled meeting on August 24, 2016. Staff feels that this option does not allow sufficient time to post the Notice of Vacancy and adequate time for interested parties to complete the package.

# **RECOMMENDATION**

Staff recommends that the Board make a motion to direct staff to post a Notice of Vacancy and schedule an open session meeting to fill the vacancy by appointment at a Board of Directors Meeting.
