5.2 Fire Chief's Report

Chief Thompson reported the Department responded to 194 calls for assistance during August. There were four significant alarms reported for the month, one of which involved a traffic accident and a subsequent second incident as a result of a distracted driver who ran into a patrol car at full speed. Chief Thompson reminded the public to slow down when nearing traffic accidents. During the month of October, the Fire Department will be visiting preschools and elementary schools teaching the importance of fire safety. LAFCO approved the District's request for an application fee reduction. The costs will be absorbed by the current fiscal year budget. Staff has determined that maintaining an Election Reserve is in the best interest of the District should there be a required vote as part of the LAFCO process. The annual Firefighters Pancake Breakfast and Pioneer Days Parade will be held 6:00 am – 10:00 am on October 17th. An open house at the Lear Station will be held October 9th from 5:00pm - 7:00 pm.
